### **Frequently Asked Questions:**

Does DJB have sufficient water for 24x7 supply?

**YES,** Delhi's per capita water supply is more than the most other cities globally. DJB has enough water to ensure 24x7 supply to the project area.

# Whether meter reading will be higher in 24x7 supply?

**NO**, Accurate metering shall be done and consumer shall be billed for the actual consumption.

## Is it proposed to privatize water supply in Delhi?

**NO**, It is not the privatization of water supplies in Delhi. DJB shall continue to hold total ownership & control of all existing and newly created assets. DJB will remain responsible to provide water service to public. The tariffs shall remain same across Delhi and shall be independent of operator's fee .DJB will pay to operators as per performance basis against prespecified targets. All regulatory powers for water connections/disconnections, sewer connections shall remain with DJB only.


