

## SPML Infra Secures New Orders worth Rs. 596 Crores

- Rs. 178 Cr order from Delhi Jal Board for supply, installation and maintenance of water meters in Delhi
- Rs. 122 Cr order from PHED, Jaipur for extension of water treatment plant from existing 400 MLD to 600 MLD at Surajpura in Tonk district
- Rs. 118 Cr order from PHED, Jaipur for water supply scheme to 191 villages and their dhanies in Tonk district with Operation & Maintenance for 9 years
- Rs. 97 Cr order from PHED, Jaipur for water supply scheme to 72 villages and their dhanies in Nagaur district with Operation & Maintenance for 10 years
- Rs. 81 Cr order from PHED, Ajmer for cluster water supply to 74 villages of Sikar district

**Gurgaon, April 15, 2013:** SPML Infra Ltd., India's leading infrastructure development company has won new orders worth Rs. 596 Crores from Delhi Jal Board and PHED, Rajasthan. The combined orders received from PHED, Jaipur and Ajmer of Rs. 418 Crores is for water supply schemes to more than 337 villages and their dhanies in the districts of Nagaur, Tonk and Sikar. The second order of Rs. 27 Crores are for supply, installation and 4 year maintenance of bulk water meters with remote reading device capable of transmitting data of various sizes.
