Rs. 594 Cr order from Bhavnagar Irrigation Project Division, Gujarat for Water Supply Infrastructure development

Rs. 127 Cr order from South Bihar Power Distribution Company Ltd. for strengthening, improvement and augmentation of electricity distribution system in 11 towns in Bihar

Gurgaon, India - SPML Infra Ltd., India's leading infrastructure development company has received two new orders worth Rs. 721 Crores from Bhavnagar Irrigation Project Division, Gujarat and from South Bihar Power Distribution Company Ltd., Patna.

Rs. 594 Cr order from Gujarat is for developing infrastructure for water supply to Bhavnagar. This project is part of Saurashtra-Narmada Avtaran Irrigation Yojana (Sauni Yojana) that has been initiated by the Govt. of Gujarat to divert excess over flowing flood water of Narmada River to allocated Saurashtra region. Excess over flowing flood water of Narmada River will be brought to Dholidhaja Dam near Surendra Nagar and will be distributed to 115 reservoirs of seven districts of Saurashtra through 1,115 km long four link canals benefitting 10,22,589 acres of land. The scope of this project includes laying of 40.75 kms MS Pipeline of 3000 mm diameters with plate thickness of 17.5 mm apart from 13,475 m³/hr Pumping Station at Chainage 30.9 Km. SPML will also be responsible for 66 KV outdoor type substations with all allied works and operations & maintenance for 10 years after the commissioning.

Rs. 127 Cr order from Bihar under the R-APDRP (Part-B) Scheme is for survey, network design, installation, erection, testing, commissioning including performance test of all the equipment supplied under the supply contract for strengthening, improvement and augmentation of electricity distribution system in 11 towns (Sultanganj, Banka, Naughachiya, Munger, Sheikhpura, Barbigaha, Jamalpur, Lakhisarai, Jhajha, Barhiya and Jamui) under Bhagalpur Electric Supply Area in Bihar on turnkey basis. The scope of work includes repair & maintenance of selected existing 33/11 KV PSS; augmentation of power transformer capacity from 3.15MVA to 5MVA & 5 MVA to 10 MVA in selected existing 33/ 11 KV PSS; additional 11 KV bays in existing 33/11 KV PSS; 11kV capacitor banks in selected 33/11 PSS; new 33 KV & 11 KV feeders (O/H, U/G & ABC); conversion, reconductoring, rearrangement of selected 33kV & 11kV lines by U/G cable/ABC; new 11/0.4 kV distribution substations of 200/100/63 KVA; augmentation of existing 11/0.4kV distribution transformer; rearrangement of LT line by AB cable/ACSR

Rabbit Conductor; single phase & three phase energy meters and service lines and all other allied supplies & works.
