SPML Infra Received New Orders worth Rs. 1232.3 Crores

- ⇒ Rs. 1002.17 Cr combined orders from Uttar Pradesh Jal Nigam, Agra
- ⇒ Rs. 230.13 Cr order from Sardar Sarovar Narmada Nigam Ltd., Gandhinagar

Gurgaon, September 2, 2014: SPML Infra Ltd., India's leading infrastructure development company has won new orders worth Rs. 1232.3 Crores from Uttar Pradesh Jal Nigam, Agra and Sardar Sarovar Narmada Nigam Ltd., Gandhinagar. The two orders (5B and 5C) received from UP Jal Nigam worth Rs. 1002.17 Crores are for augmenting drinking water supply for Agra city with laying of 128 kilometers of water pipeline. The 230.13 Cr order from Sardar Sarovar Narmada Nigam Ltd., Gandhinagar is for infrastructure development for hydro generating units at Kutchh, Gujarat.

The Agra water supply project is planned to transport sufficient volumes 150 cusecs of Ganga water to Agra from Palra Fall on the upper Ganga Canal to Mathura and 140 cusec onward to Agra to cater to the population of Agra with the planned reduction in water leakage and further savings in water wastage. SPML' scope of work of contract 5B includes supply and construction of two parallel 2100 mm diameter mild steel conveyance main of 96 kilometers (48 km each side of twin pipeline) which will further extend to Mathura Water Treatment Plant under a different contract. The scope of work under contract 5C includes supply and construction of 2800 mm diameter mild steel conveyance main of 32 kilometers. This project is executed with foreign aid from Japan International Cooperation Agency (JICA). SPML will be executing this project with its JV partner, Megha Engineering Infrastructure Limited.

The Gujarat order is for construction of three hydro power plants with combined capacity of 23 MW in Kutchh. The scope of work includes civil, electrical and mechanical construction with design, engineering, testing and commissioning of three small hydro power projects with 5 years of operations & maintenance. SPML will execute this project in partnership with Om Metals Infraprojects Limited.

Mr. Rishabh Sethi, Chief Operating Officer, SPML Infra, commented, "Water management including transmission and distribution is our core competency and we have already laid more 4000 kilometers of cross country water pipelines of various size and length in all terrains. The latest order from UP Jal Nigam is a testimony of our expertise in strong and sustainable infrastructure development. Our experience of developing infrastructure for hydro power plants in Himachal Pradesh, Karnataka, Mizoram and Uttrakhand has helped us to receive the order of 3 hydro power plant constructions from Gujarat. These new orders from our esteemed clients will further boost our efforts in developing sustainable infrastructure that will help providing drinking water to a large population of Agra city and power from renewable sources in Gujarat."
