- SUB: independent Auditor's Report on proposed issue of up to 27,75,000 Equity Shares and up to 34,04,930 0% Compulsorily Convertible Preference Shares (CCPS) on a preferential basis in accordance with the provisions of Chapter V of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations 2018 and amendments thereto
- I, Shailashri Bhaskar, Practising Company Secretary have been requested by SPML Infra Limited ("the Company") having its registered office as mentioned above, vide mandate letter dated January 24, 2022, to certify that the proposed preferential issue of equity shares and 0% Compulsorily Convertible Preference Shares (CCPS) convertible into equity shares on conversion of unsecured loan advanced by the allottees (collectively referred to as "Preferential Issue") are in compliance with the requirements of "Chapter V Preferential Issue" of Securities and Exchange Board of India ("SEBI") (Issue of Capital and Disclosures Requirement) Regulations 2018 as amended from time to time ("the ICDR Regulations"). In accordance with Regulation 163(2) of the ICDR Regulations, the certificate is to be placed before the general meeting of the shareholders considering the proposed preferential issue.

Management's Responsibility

- 2. The preparation of the Statement in accordance with chapter V of the ICDR Regulations is the responsibility of the Management of the company including the preparation and maintenance of relevant supporting records and documents. Further, my scope of work did not involve performing audit tests for the purpose of forming an opinion on the fairness or accuracy of any of the financial information or the statements of the Company, taken as a whole.

- 6. The procedures performed in a limited assurance engagement vary in nature and timing from and are less in extant than for, a reasonable assurance engagement. Consequently, the level of assurance obtained from a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed. Accordingly, I have performed the following procedures in relation to the proposed preferential issue:
- i. Verified the minutes of the meeting of the Board of Directors held on January 21, 2022 approving the preferential allotment and verified that the Company has determined the 'Relevant Date' as defined in Chapter V of SEBI ICDR Regulations as January 22, 2022 in respect of the proposed preferential issue of up to 27,75,000 Equity Shares and up to 34,04,930 0% Compulsorily Convertible Preference Shares (CCPS);
- ii. Obtained the certified copy of the resolution passed at the meeting of Board of Directors held on January 21, 2022 in respect of the proposed preferential issue of up to 27,75,000 Equity Shares and up to 34,04,930 0% Compulsorily Convertible Preference Shares (CCPS) at a price of Rs.50 per share to the allottees by way of conversion of outstanding unsecured loan;
- iii. Obtained the copy of the notice of the EGM of the shareholders for the proposed preferential issue of up to 27,75,000 Equity Shares and up to 34,04,930 0% Compulsorily Convertible Preference Shares (CCPS) approved by Board of Directors in their meeting held on January 21, 2022;

- vi. Obtained a copy of letter dated January 24, 2022 from the Registrar and Share Transfer Agents providing beneficial shareholding positions of the proposed allottees for the period from July 22, 2021 to January 21, 2022, i.e. six months preceding the Relevant Date and that the holding of the proposed allottees are pledged with the lenders;
- vii. Statement of Holdings of the Allottees as on January 21, 2022 the Relevant Date.
- viii. Downloaded the data of the Trading Volume of the related equity shares of the Company on the NSE and the BSE for a period of 240 trading days prior to the Relevant Date and the data on volume weighted average price of related equity shares of the Company from the official website of National Stock Exchange ('NSE') and Bombay Stock Exchange ('BSE') and computed the average of Volume Weighted Average Price and traced the same in the Statement of Computation;
- ix. Reviewed the computation of the minimum issue price determined by management based on higher of (a) or (b) below, provided as under:
 - (a) The average of the volume weighted average price of the related Equity Shares quoted on the NSE during the 90 trading days preceding the Relevant Date.

- (b) The average of the volume weighted average price of the related Equity Shares quoted on the NSE during the 10 working days preceding the Relevant Date.
- x. Verified the Certified true copy of the Articles of Association to confirm that there are no restrictive clauses with regard to the valuation of the shares proposed to be issued on a preferential basis.
- xii. Performed necessary inquiries with the management and obtained necessary representation from management.

Based on the procedures performed by me as above, and the information and explanations given to me, in my opinion; the minimum price for the proposed preferential issue is Rs. 42.42 per share as per trading Volume on NSE (the exchange in which the highest trading volume in respect of the equity shares of the Company has been recorded during the 240 trading days preceding the Relevant Date) and is computed in accordance with Regulation 164 of the SEBI ICDR Regulations.
- 8. I further certify that the proposed preferential issue of up to 27,75,000 Equity Shares and up to 34,04,930 0% Compulsorily Convertible Preference Shares (CCPS) is being made in accordance with the requirements of SEBI (ICDR) Regulations, 2018 as amended from time to time.
