# CONSOLIDATED SCRUTINIZER'S REPORT FOR VOTING THROUGH ELECTRONIC MEANS

Dear Sir,

I, <u>Tumul Maheshwari</u>, Practicing Company Secretary having office at <u>35/2</u>, <u>Street No. 6</u>, <u>Friends Colony Industrial Area</u>, <u>Shahdara</u>, <u>Delhi-110095</u> have been appointed as Scrutinizer Pursuant to the Resolution passed by the Board of <u>SPML Infra Limited</u> (hereinafter referred to as the "Company") on <u>11<sup>th</sup> August 2022</u>, for the purpose of scrutinizing the e-voting process taken pursuant to section 108 of the Companies Act, 2013 and rule 20(3) of the Companies (Management and Administration) Rules, 2014. I, also state that I am familiar and well versed with the concept of electronic voting system as prescribed under the said Rules.

M/s. Maheshwari Datamatics Private Limited is the Registrar and Share Transfer Agent (RTA) of the Company and M/s. National Securities Depository Limited (NSDL) is the Service Provider for providing the facility of electronic voting to the shareholders of the Company.

The Service Provider, had provided a system for recording the votes of the shareholders electronically on all the items of the business (Special businesses) sought to be transacted in the Annual General Meeting (AGM) of the Company, which was held on 26<sup>th</sup> September 2022. The Service Provider accordingly had set up e-Voting facility on their website, <a href="https://evoting.nsdl.com">https://evoting.nsdl.com</a>. The Company had uploaded all the items of the business to be transacted on the website of the Company and also its Service Provider to facilitate their shareholders to cast their vote through e-Voting.

The Company has sent the Notice of the AGM to  $\underline{11,631}$  Shareholders on  $\underline{4^{\text{th}}}$  September  $\underline{2022}$  as per the details available with the RTA/Service Provider through e-mail. The notices which were sent contained the detailed procedure to be followed by the shareholders who

were desirous of casting their votes electronically as provided in the Rule 20 of the Companies (Management and Administration) Rules, 2014.

The Cut-off date (record date) for the purposes of identifying the shareholders who will be entitled to vote on the resolutions placed for approval of the shareholders was 19<sup>th</sup> September, 2022. As prescribed in the Rules, the Company also released an advertisement, which was published in the English and Hindi language newspaper viz. Business Standard (English & Hindi), carrying the required information as specified in the rules. As prescribed in the aforesaid Rules, the e-Voting facility was kept open from Friday, the 23<sup>rd</sup> September, 2022 at 09:00 A.M. and ends on Sunday, the 25<sup>th</sup> September, 2022 at 05:00 P.M. At the end of the voting period on 25<sup>th</sup> September, 2022 the portal of the Service Provider was blocked forthwith. On Monday 26<sup>th</sup> September, 2022 after the end of the AGM and the additional time allowed (15 minutes) for e-voting, the votes cast through e-Voting facility was duly unblocked by me as a Scrutinizer in the presence of two witnesses, as prescribed in Sub Rule 4(xii) of the said Rule 20.

The management of the Company is responsible to ensure that compliance, with the requirement of the Companies Act, 2013 and rules made thereunder, relating to voting through electronic means. My responsibility as a scrutinizer for the remote e-voting process is restricted to make a Scrutinizer's report of the votes cast "in favour" or "against" the resolution and "invalid" and "abstained" votes, based on the reports generated from remote e-voting process system provided by National Securities Depository Limited.

As a Scrutinizer the report of the e-Voting carried out by the shareholders was duly compiled, the details of which are as follows:

There were in all <u>193</u> shareholders holding <u>1,84,96,500</u> equity shares of the Company, who have participated in the voting process for the AGM through e-Voting.
