SPML Infra has signed agreement with the Public Health Engineering Department (PHED), Rajasthan for a large water supply project under the Jal Jeevan Mission. The Isarda Water Supply project, under the Jal Jeevan Mission would provide clean drinking water to 25 lakh people in Dausa and Sawai Madhopur districts in Rajasthan.

The project valued at Rs 1,157.80 crore (\$151.60 million) is aimed to provide clean drinking water facilities to about 25,00,000 people residing in 1,256 villages and six towns of Dausa and Sawai Madhopur districts in Rajasthan.

The project will be completed within the stipulated 24 months period (3 per cent incentive will be given for completing before timeline) and after the defect liability in a year period, SPML Infra will be responsible for managing the operation and maintenance of the project for next 10 years' time.

GR Bhimasar Bhuj Highway and GR Madanapalli Pileru Highway, wholly owned subsidiaries of GR Infraprojects, are in receipt of letter from National Highways Authority of India for noting of financial close for their projects.

The project is upgradation to four lane with paved shoulder of NH 341 from Bhimasar junction of NH 41 to Anjar-Bhuj up to airport junction, in Gujarat on hybrid annuity mode. Bid project cost is Rs 1085 crore.

Further, the completion period is 910 days from the appointed date and operation period is 15 years from commercial operation date.

The second project is construction of four laning of NH 71 from Madanapalli to Pileru Package I on HAM mode in the state of Andhra Pradesh under Bharatmala Pariyojna. Bid project cost is Rs 1577 crore.

Further, the completion period is 730 days from the appointed date and operation period is 15 years from commercial operation date.

It completed the project on the development of Purvanchal Expressway (Package VII) from Mojrapur (Azamgarh district) to Bijaura (Ghazipur district) in Uttar Pradesh on EPC basis.
